

## **System Requirements**

- Slimport®/MyDP enabled video source device (i.e. Smartphone, Tablet)
- HDMI® enabled video display device (i.e. television, projector)
- HDMI® Cable (male/male)
- (Optional) Micro USB Cable (Typically included with Smartphone or Tablet)

## **Hardware Installation and Operation**

- 1. Connect the "SlimPort/MyDP Breakout Cable" to the Micro USB Port on your Slimport/MyDP-enabled video source device.
- 2. Connect an HDMI® Cable (m/m) from the "HDMI® Output Port" on the SLMPT2HD, to the HDMI® input port on your HDMI®-enabled video display device (i.e. television, projector).
- 3. (Optional) If you would like to provide power to your smartphone or tablet while connected to the SLMPT2HD, connect a USB Power source to the "Micro USB Power Port" on the SLMPT2HD using the USB A to USB Micro B cable included with your mobile device.
- 4. The Slimport/MyDP-enabled device output will now appear on the HDMI® display.
