Terms and Conditions

Definitions

"The Company" and "The Promoter" is Easy Computers Ltd, trading as Laptops Direct, Acer Direct, Direct TVs, Appliances Direct, Server Direct, AirCon Direct & Shop Targus

Terms and Conditions

- 1. Subject to the remainder of these terms and conditions customers can claim the cash back amount on The Companies 'Qualifying Products' (see full list at www.laptopsdirect.co.uk/sony_cashback/page.asp offer dated October 2008) purchased between 3rd and 19th October 2008. Customers may claim cash back for a maximum of 1 unit per qualifying product during the period of the promotion. This offer can not be combined or used in conjunction with any other cashback offer.
- 2. To take advantage of the promotion, customers must print out and complete the claim form (which can be downloaded at www.laptopsdirect.co.uk/sony_cashback/page.asp) and send it registered post, along with proof of purchase and proof of delivery to the address set out in the claim form. Proof of order or despatch will not be accepted. The invoice must clearly show the qualifying products purchased, the purchase price and the date of purchase. In addition, proof of delivery must also be supplied this is the delivery sticker from the box your goods have been delivered in. The participant must not send original receipts.
