Terms and Conditions

1. Subject to the remainder of these terms and conditions customers can claim the cash back amount on HP 'Qualifying Products' (see full list at www.hp.com/uk/morepc offer dated 1 February – 30 April 2007) purchased between 1 February and 30 April 2007. Customers may claim cash back for a maximum of 50 qualifying products per product group (Workstations, Desktop PCs, TFT Monitors, iPAQs and Notebooks) during the period of the promotion.
2. To take advantage of the promotion, customers must print out and complete the claim form (which can be downloaded at www.hp.com/uk/morepc) and send it, along with proof of purchase in the form of the seller/reseller's invoice or receipt to the address set out in the claim form. Proof of order or dispatch will not be accepted. The seller/reseller's invoice/proof of purchase must clearly show the qualifying products purchased, the purchase price and the date of purchase. The participant must not send original receipts. HP must receive the claim form within 30 days from the date of purchase.
3. The promotion is valid in respect of qualifying products purchased either directly from HP or an authorised reseller or retailer of HP. Purchases direct from HP distribution partners are ineligible.
